It is our intention to drill Well No. 10 to approximately 9950' to test the Pictured Cliffs formation. Our casing program is as follows:

200' of 10-3/4" OD 12.75# casing, cemented with 150 lbs. regular cement, to be circulated.

9950' of 5-1/2" OD 14# casing, cemented with 250 sacks cement.

The designated drilling unit is the SE 1/4 - NE 1/4 of Section 29-29N-3W, Rio Arriba County, New Mexico.

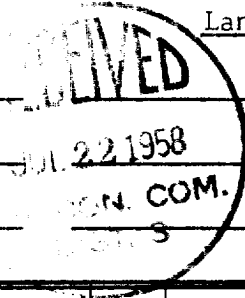

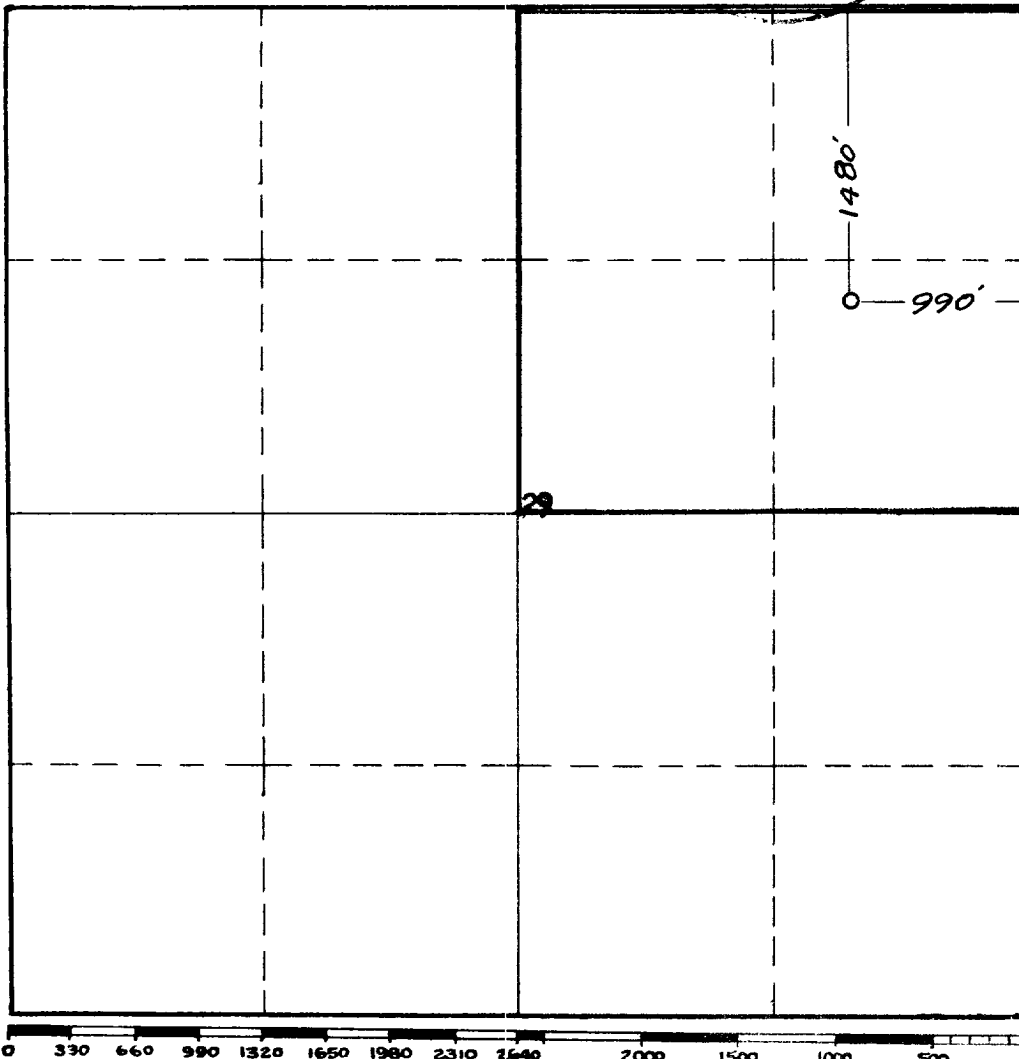
