

DETAILS OF WORK

It is our intention to drill Well No. 17 to approximately 4800' to test the Mamfex formation. Our casing program is as follows:

300' of 10-3/4" OD casing with 300 sacks cement to be circulated.
4800' of 5-1/2" OD L&L casing - cemented with 800 sacks cement.

The designated drilling unit is the SW 1/4 of Section 28-28N-5W, Rio Arriba County, New Mexico.


