In accordance with the provisions of Order No. R-1214, dated July 3, 1958 amending Rule 112-A for multiple completions, it is respectfully requested that Skelly Oil Company be granted administrative approval to dually complete the Jicarilla "C" Well No. 17, located in Unit L, Section 28, T25N, R5W, in the Pictured Cliffs and Chacra zones.


A packer leakage test will be submitted to the District Office in Aztec, New Mexico.

NOTE: If the proposed dual completion will result in an unorthodox well location and/or a non-standard proration unit in either or both of the producing zones, then separate application for approval of the same should be filed simultaneously with this application.


