### DETAILS OF WORK

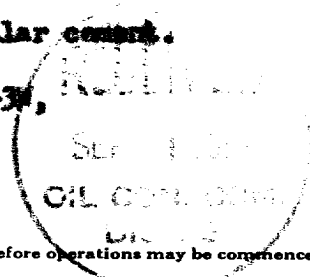

200' of 10-3/4" OD casing, 32.75# cemented with 150 sacks of regular cement. Cement to be circulated.

3950' of 5 1/2" OD, 14# casing cemented with 200 sacks regular cement.

The designated drilling unit is the SW/4 Section 20-25N-3W, Rio Arriba County, New Mexico.

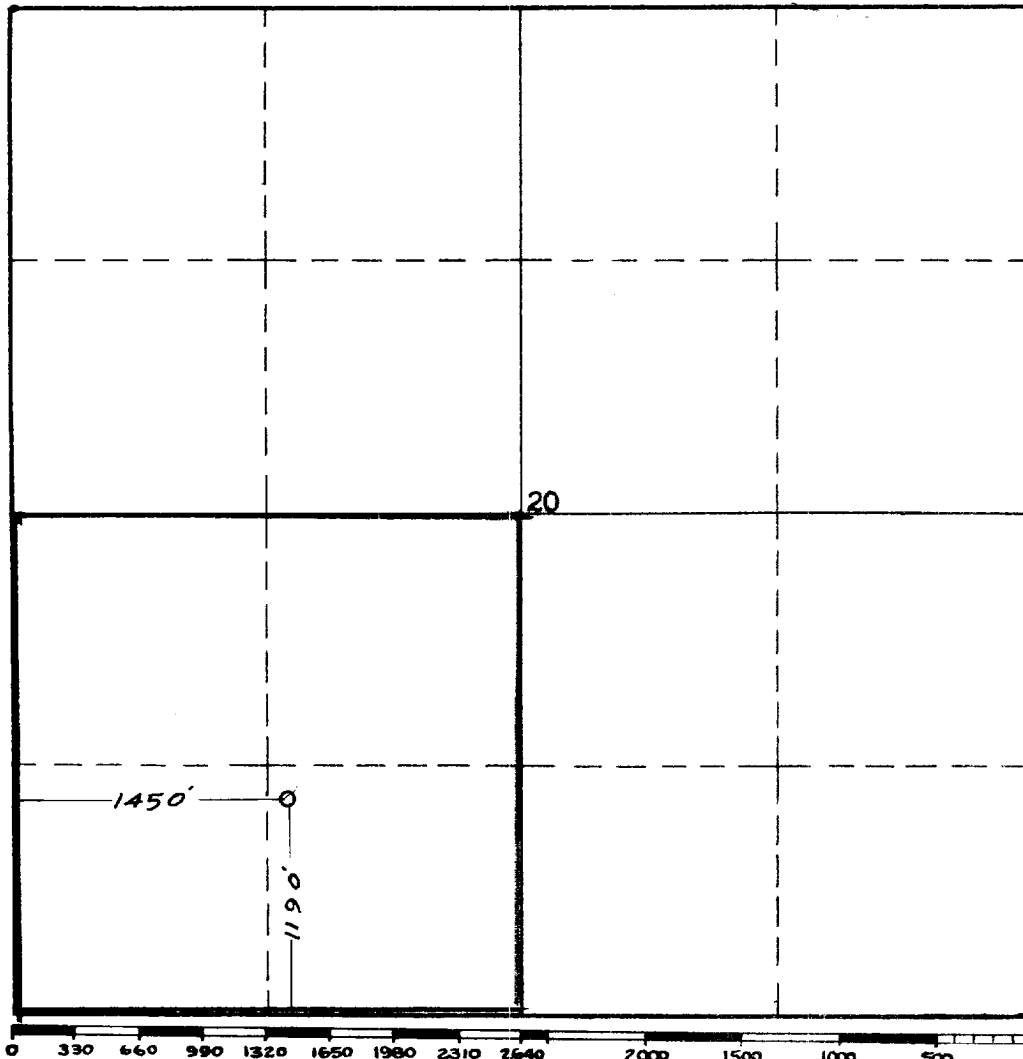
