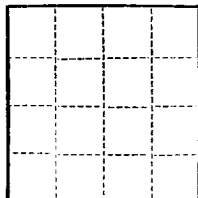

It is our intention to drill well No. 5 to approximately 3950' to test the Pictured Cliffs formation. Our casing program is as follows:

200' of 11-3/4" O.D. casing, 32.75% cemented with 150 sacks of regular cement. Cement to be circulated.

3950' of 5 1/2" O.D., 11 1/2" casing cemented with 200 sacks regular cement.

The designated drilling unit is the NE 1/4 Section 20-25N-3E, Hio Arriba County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

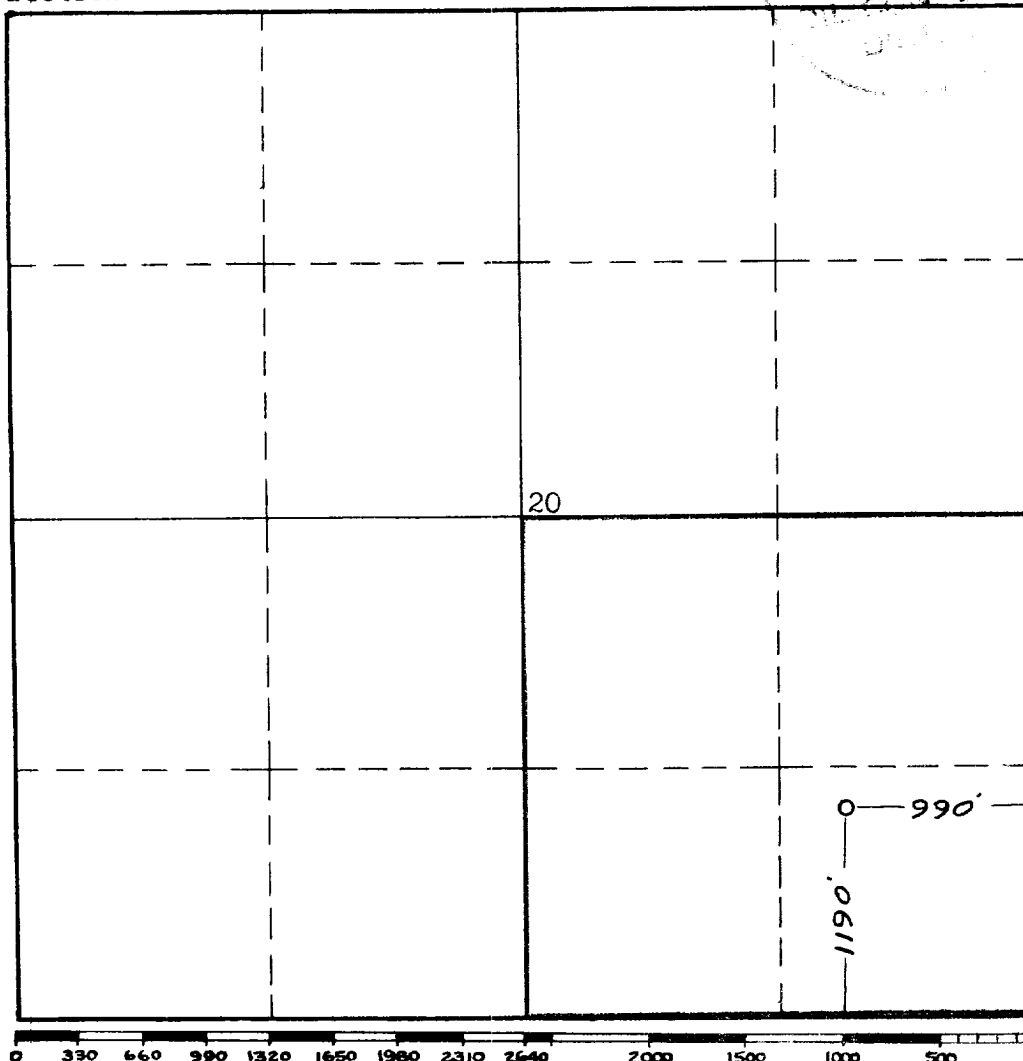
