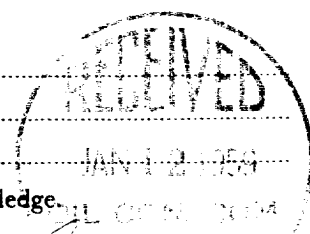

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were cultured in the YEA medium for 24 h and then adjusted to the concentration of 1×10^8 cells/ml. The cells were then mixed with the plant protoplasts at the ratio of 1:10. The plant protoplasts were then cultured in the YEA medium for 24 h. The transformation efficiency was determined by the number of colonies formed on the YEA medium. The results are shown as the mean \pm SD of three independent experiments.
