It is our intention to drill Well No. 4 to approximately 8200' to test the Dakota formation. Our casing program is as follows:

300' of 13-3/8" OD casing, 40#, cemented with 350 sacks regular cement, to be circulated.

8200' of 5-1/2" OD casing, 17#, cemented with 700 sacks cement in 2 stages.

The designated drilling unit is the NE/4-NE/4 of Section 19-25N-3W, Mio Arriba County, New Mexico

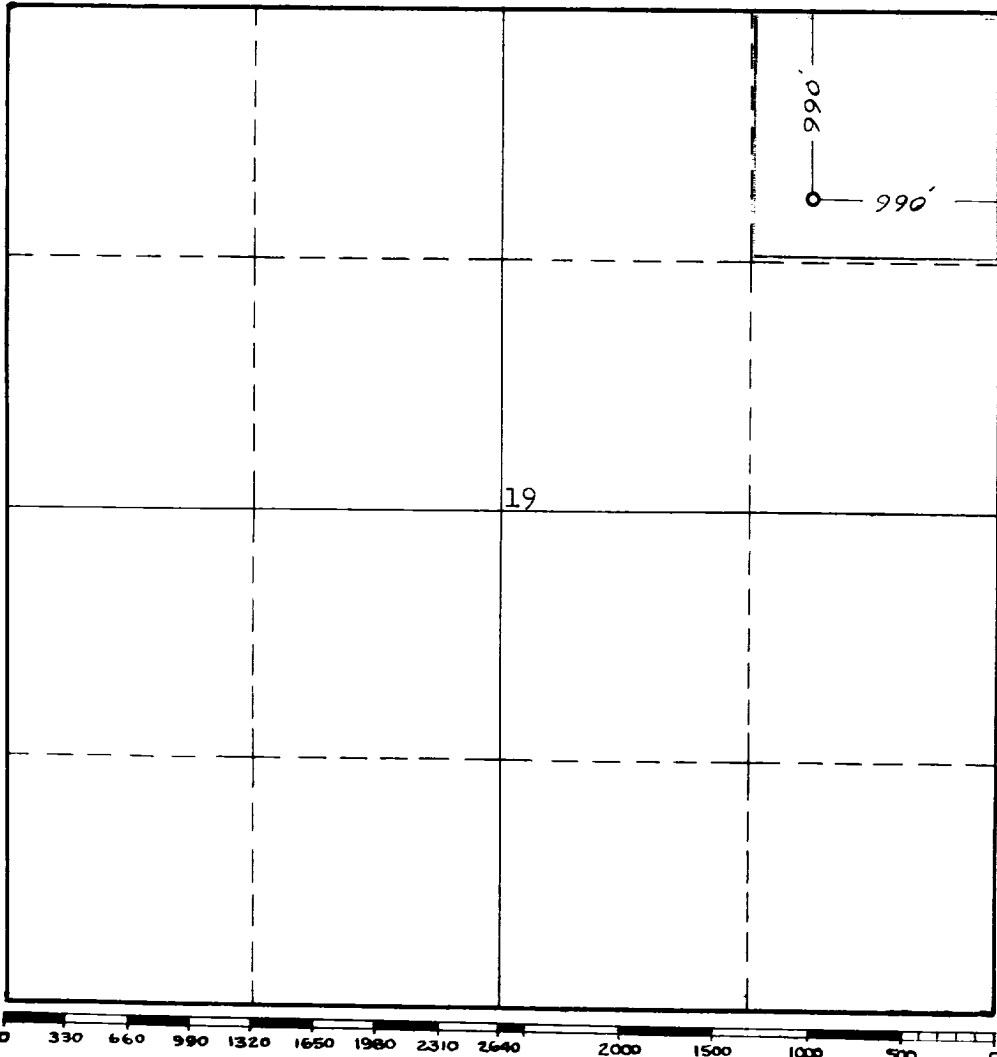
