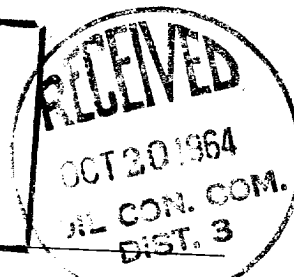
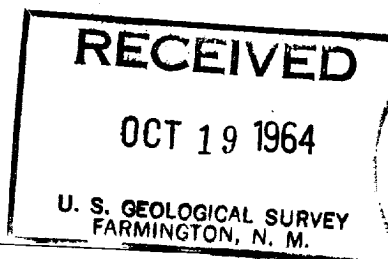

8-22-64 Temperature survey showed top of cement at 4050'.

8-23-64 Pressured up on casing to 1000#. No pressure decrease in one hour.
