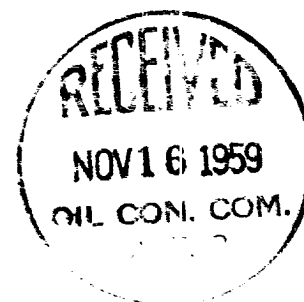

It is intended to plug and abandon this well in the following manner:

1. Spot 25 sacks of cement across pay interval.
2. Find free point and cut off casing.
3. Spot cement plug on casing stub and pull casing.
4. Spot 100' cement plug at surface.
5. Install permanent 4' x 4" marker.
