April 8, 1957. After drilling to 2,407' with rotary rig, ran Schlumberger. Top of Pictured Cliffs at 2,317'. Set 2 joints (61') of 5-1/2" O.D. 15.5# J-55 casing and 57 joints (2,034') of 5-1/2" O.D. 14# J-55 casing at 2,404' RKB with 100 sacks cement. Moved rig off. Will Complete with cable tools at later date.
