Until Notice of Release of Shut-In is issued on Shut-In Order SF 3942, by the Commission, if more than 500 MCF of gas is produced during any month, the special authority granted by this order shall be automatically revoked and the above well shut in until all overproduction is made up.

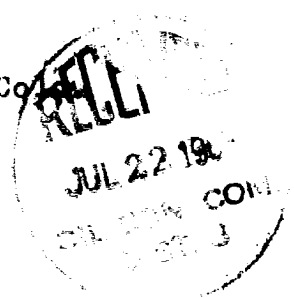
