DETAILS OF WORK

Drill with mud rotary 8-1/4" hole. Set 3 joints (approx 90') 7" 23# J55 casing, or deep enough to set approximately 1 joint in solid rock, whichever is the lesser. Cement by circulation to surface. Then drill 6 1/4" hole to test Gallup at approx. 1300' and if production encountered, set and cement string of 4" casing.

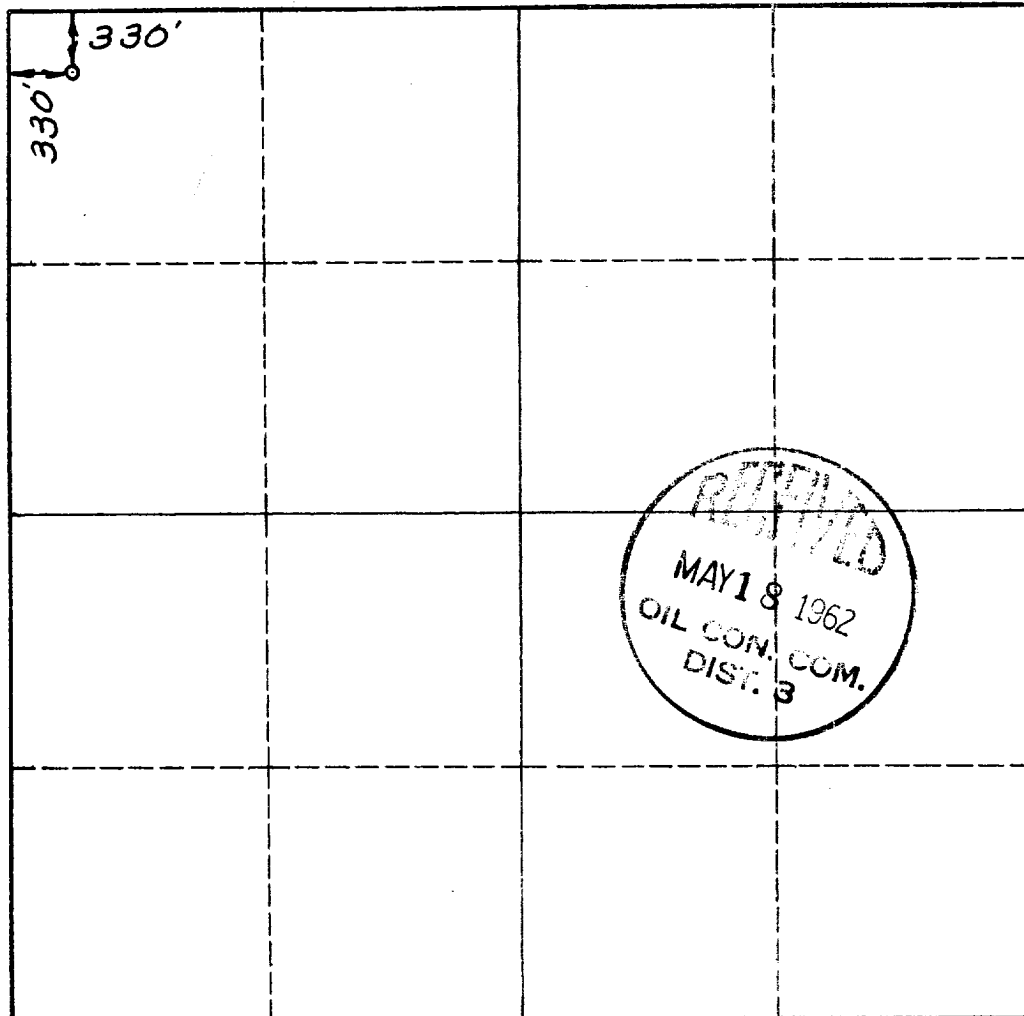

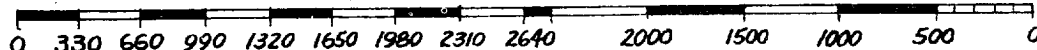
