We propose to drill this well to an estimated depth of 7600' to further develop the Gallup and Dakota reservoirs and prove additional acreage for future development. If commercial production is encountered the well will be completed as follows: Set production casing as proposed above. Perforate and stimulate as indicated by logs. (A Model "B" packer will be set approximately 150' above the Dakota to prevent communication between the two zones.) Parallel tubing strings will be utilized to produce the two zones.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

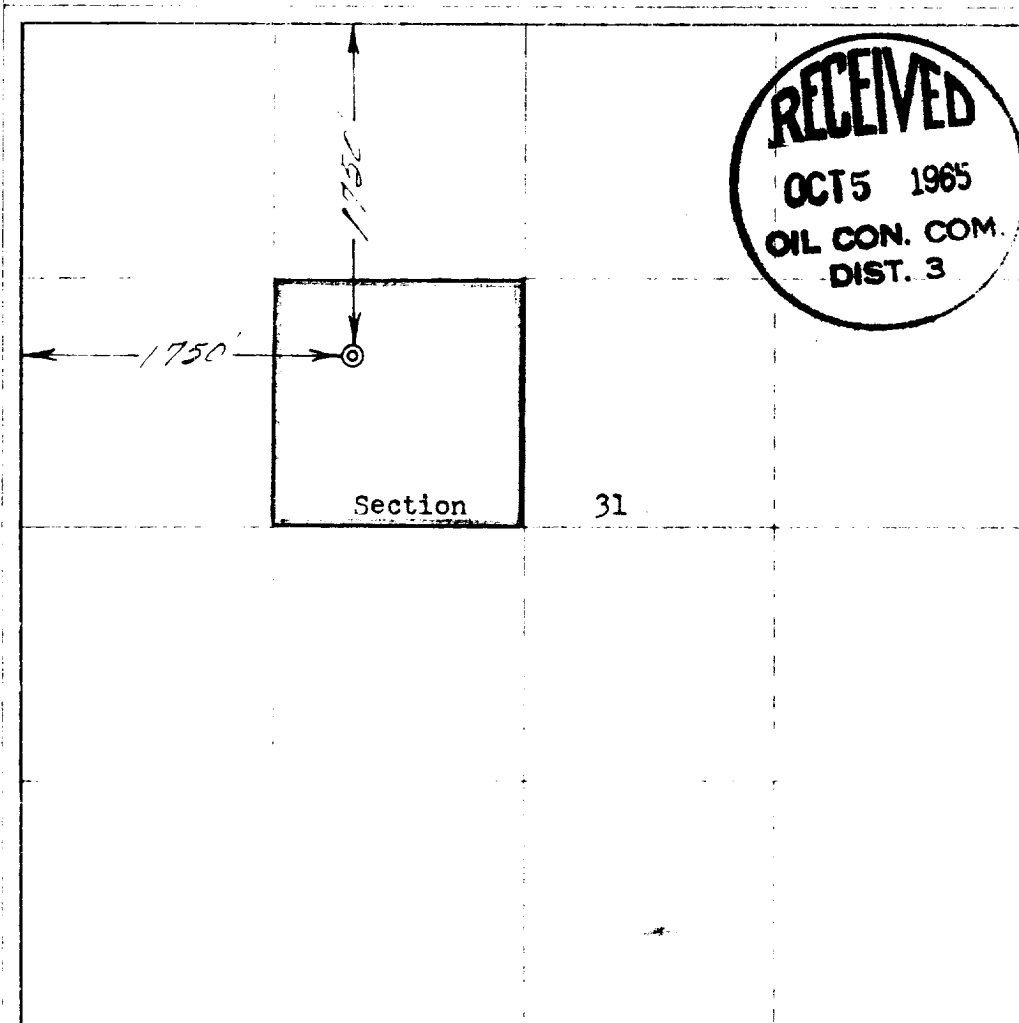
