Instructions

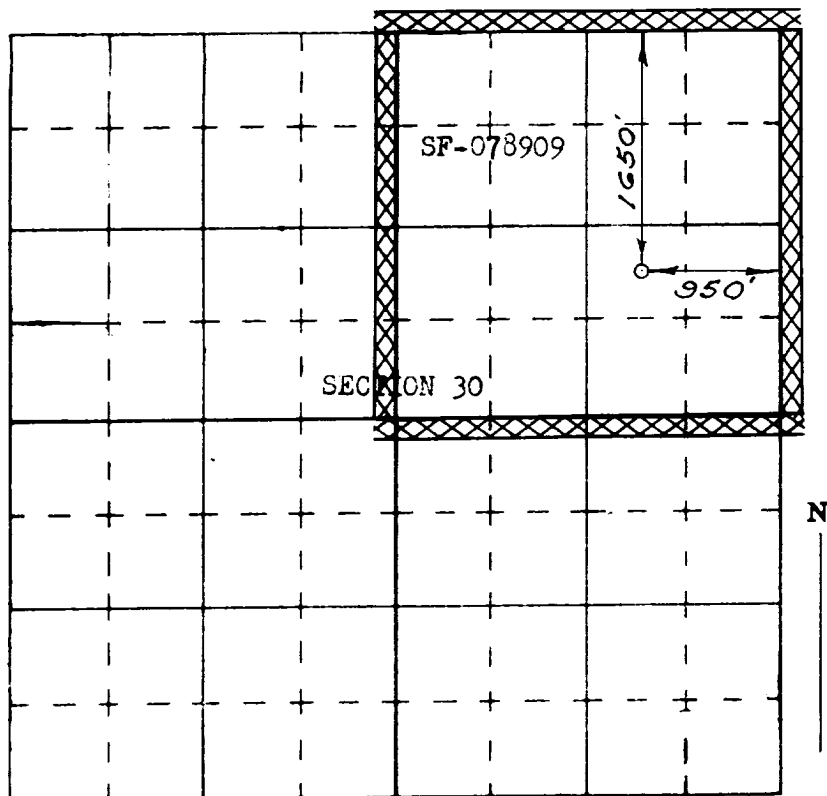
