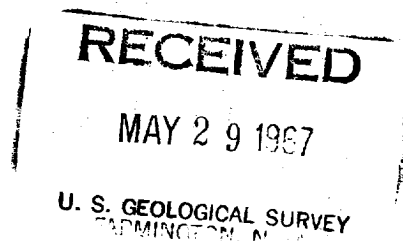

SIZE OF HOLE	SIZE OF CASING	WEIGHT PER FOOT	SETTING DEPTH	QUANTITY OF CEMENT
12 1/4	8 5/8	20.0	110	75 sacks (circulate)
6 3/4	4 1/2	9.5	2900	100 sacks

Drill 12 1/4 surface hole to 110'. Cement 110' of 8 5/8" surface casing and circulate cement. WOC 24 hours. Drill 6 3/4" hole to approximately 2900' w/ mud. Run electric log. Cement 4 1/2" esg @ 2900' w/ 100 sacks 50-50 poz. WOC 72 hours. Perforate casing opposite Pictured Cliffs sand w/ two jets/ft. Sand-water frac down casing w/ 35,000 gallons water, 30,000# 10-20 sand. Swab well in and run 1" tubing to 2850'. Shut well in to await pipeline connection.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

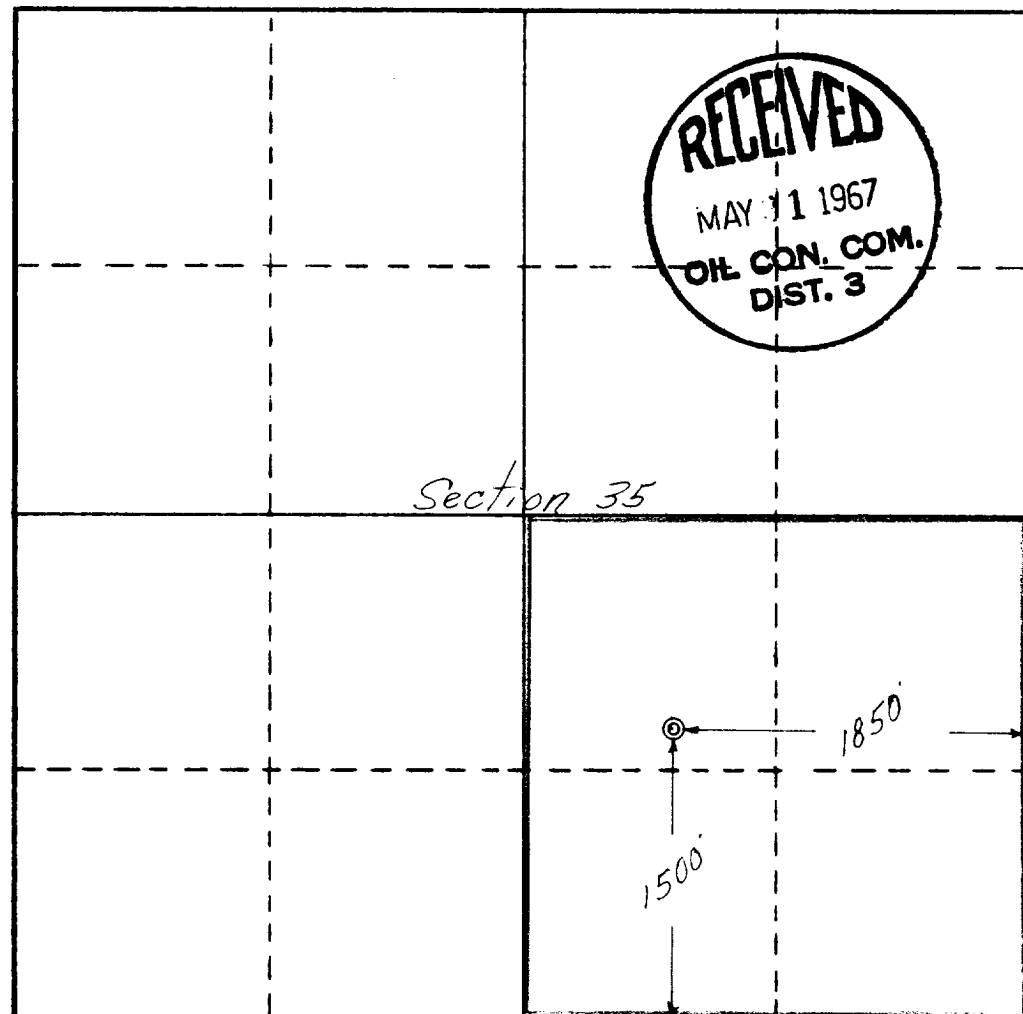
