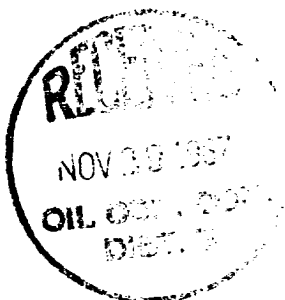
Drilled 12 1/2" hole to 212 KB and sat 200' of 8-5/8" csg w/ 160 sack cement

Drilled 6-3/4" hole to 3662' and sat 3648' of 2-7/8" csg w/ 250 sack cement

Perforated 3453-68 and 3555-70 w/ 48 holes, fraced w/ 790 barrels water and 30,000# 20-40 sand.

After blowing to atmosphere for five days gauged 1105 MCF/day.

Cleaned up location and now waiting on pipeline connection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
