Instructions

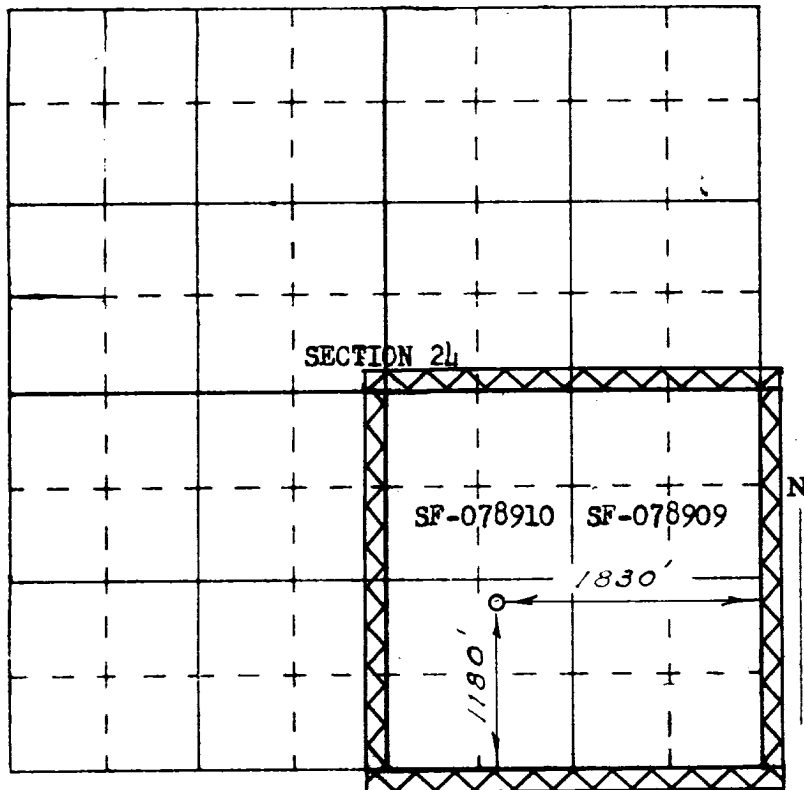
