Commenced drilling 4-17-69. 8 5/8" OD, 24# casing set at 238' RDM and cemented with 165 sacks cement, 2% CaCl₂. Plug down 2:00 A.M., 4-18-69. WOC. Tested to 800 psi for 30 minutes. Okay. Drilled to TD 7890'. 5 1/2" OD, 15.5# and 17# casing set at 7890'. Cemented first stage with 450 sacks 50-50 Pozmix "A", 2% gel, 6-1/4#/sack Gilsonite, 1/2 of 1% D-30 (F.R.). Full returns throughout. Opened two-stage and cemented with 120 sacks Liteweight, 1/2 of 1% D-30 (F.R.) followed with 300 sacks 50-50 Pozmix "A", 2% gel, 6-1/4#/sack Gilsonite, 1/2 of 1% D-30. Both stages preceded with 500 gallons Mud Sweep. Circulated 3 hours between stages. Plug down 12:45 P.M., 5-8-69. Released rig 2:00 P.M., 5-8-69.
