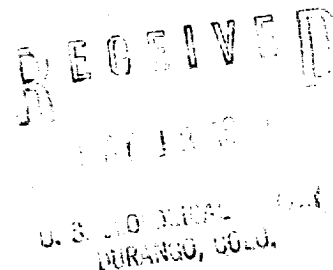

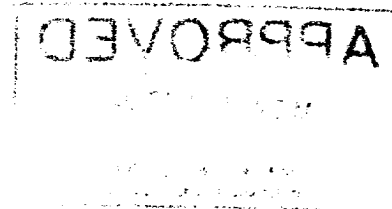
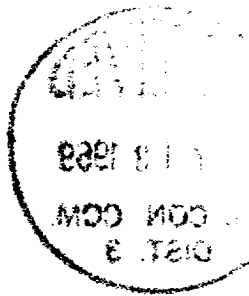

WELL LOCATION AND ACERAGE DEDICATION PLAT**

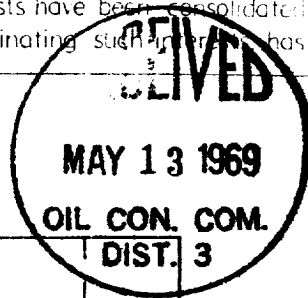

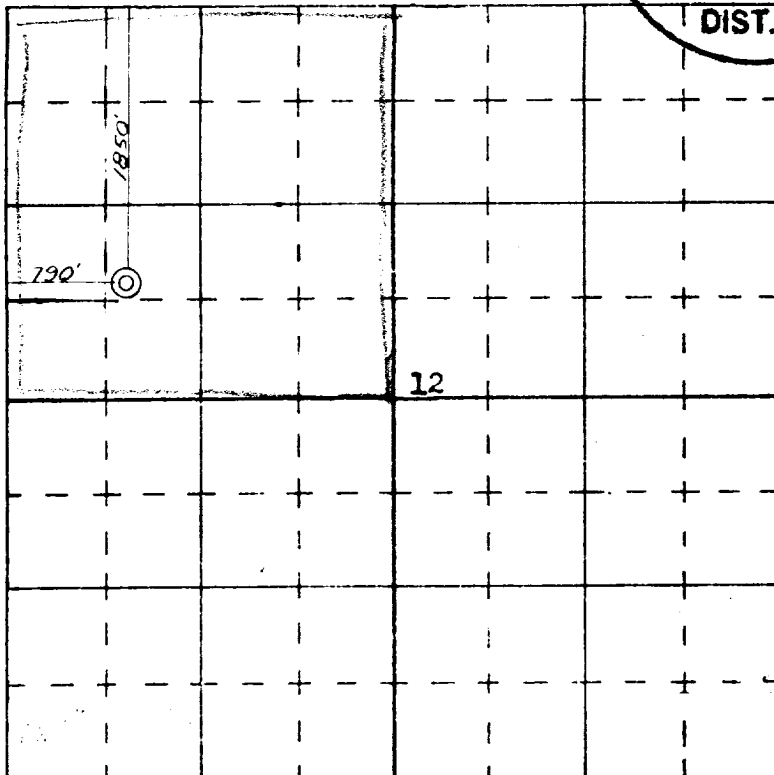
