Instructions

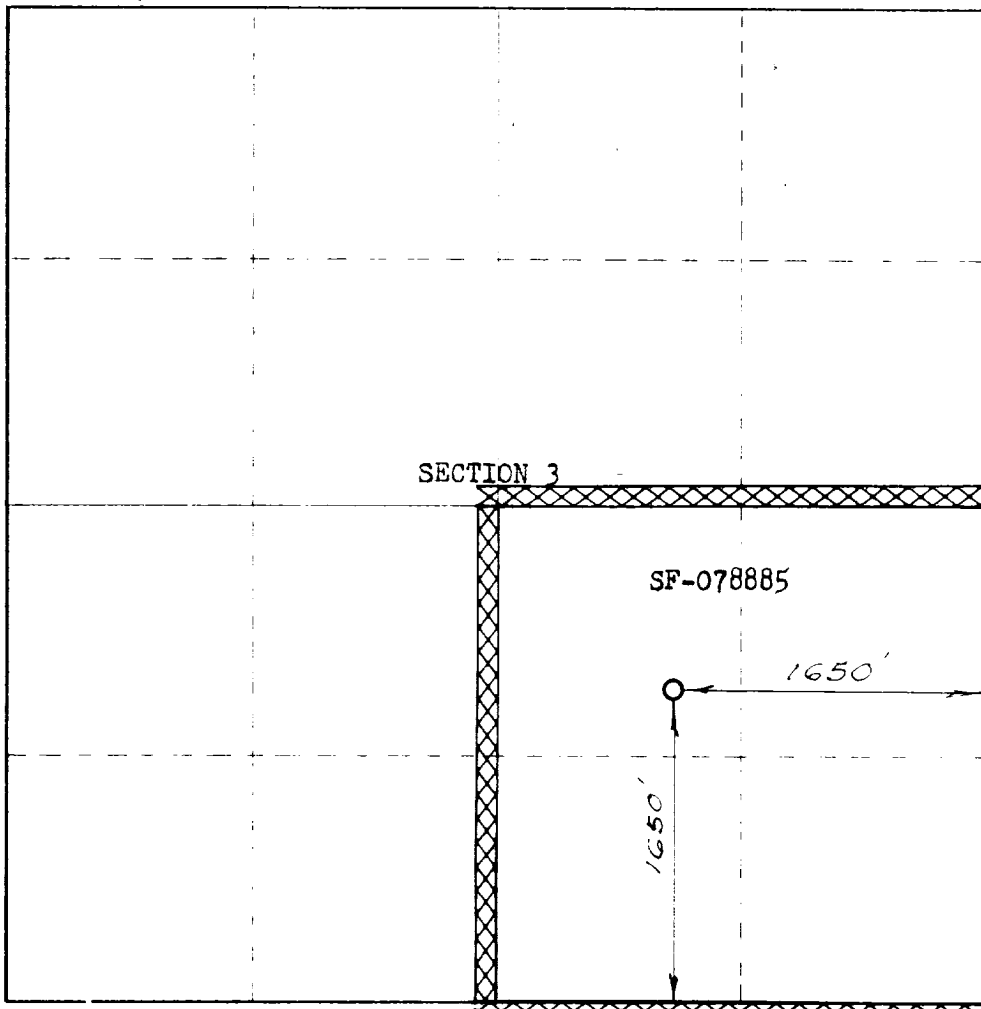
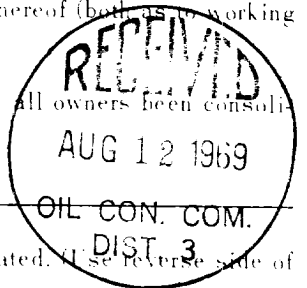
