It is intended to plug and abandon the Dakota formation and recompleat in the Gallup formation by pulling the tubing and packer, setting a cement retainer at 6720' and squeeze cement the Dakota perforations with 65 sks. of cement. The casing failure will be isolated and squeeze cemented with a sufficient amount of cement to repair the leak. Following cleanout, the casing will be tested and the Gallup formation selectively perforated and fractured. The wellbore will be cleaned out and the well returned to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
