## Instructions

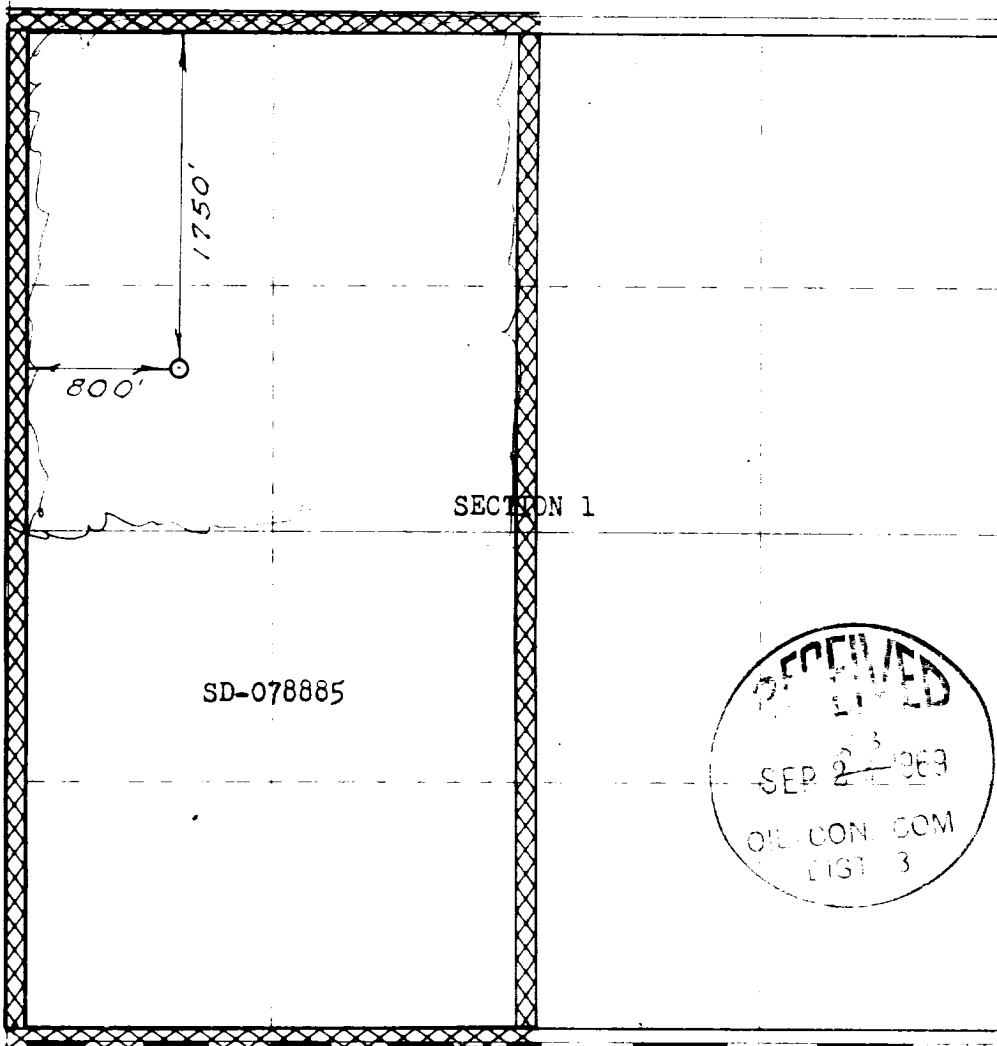

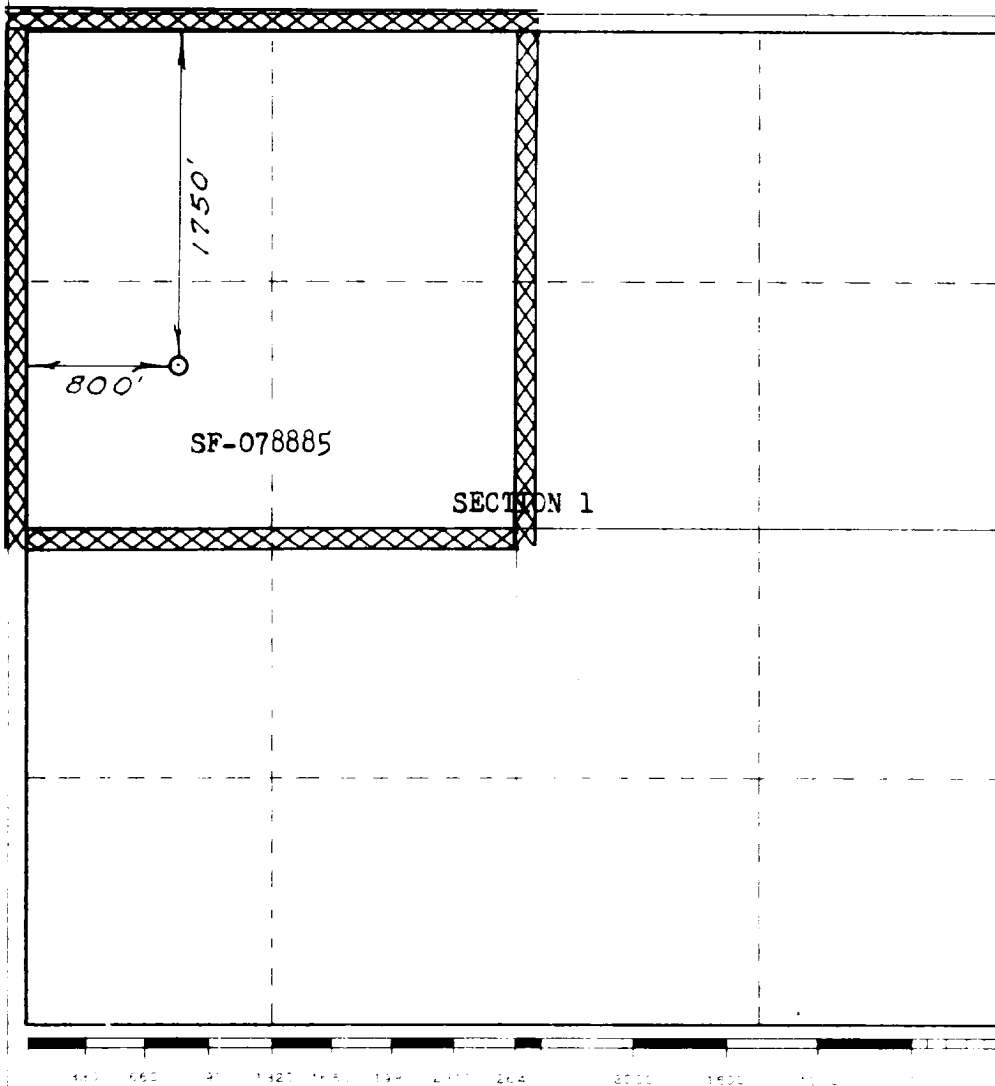
