On 4-21-70 T.D. 3876', ran 127 joints 2 7/8", 6.4", J-55 casing (3868') set at 3876' w/ 250 sacks of cement. V.D.C. until completion.

On 4-27-70 P.B.T.D. 3868'. Perf. 3716-3732' w/ 32 shots, frac w/ 20,000 20/40 sand, 20,538 gal. water. No ball drop, flushed w/ 1113 gal. water.
