7-22-70 TD 6454' RKB. Ran 154 joints 6467' of 7-5/8" OD 25.40# N-80 casing, landed at 6453' RKB, cemented with 300 sacks cement, 2% gel, 12 1/2# gilsonite and 1/2 floccle per sack, followed with 150 sacks cement, 1% gel, 12 1/2# gilsonite and 1/2 floccle per sack.

7-23-70 Pressured up on casing to 1000#. No pressure decrease in one hour. Temperature survey showed top of cement at 4350'.

Instructions
