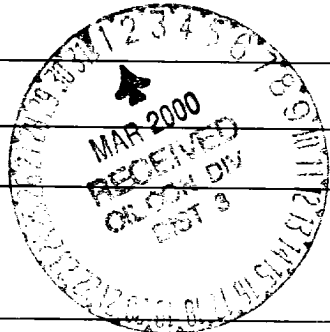

2/3/00 ND wellhead, NU BOP. Could not pull seal assembly from Model "D" packer. RU wireline, run freepoint, free @ 6749'. Run chemical cutter and cut 2 1/16" tubing at 6748'. POOH and layed down 211 jts. 2 1/16" tubing.

2/4/00 RIH w/ 4 11/16" OD overshot, latched onto fish and POOH w/ 120 jts. 2 3/8" tubing.

2/7/00 POOH recovered 100% of fish. RIH w/ mill and cut over Model "D" packer POOH to 5587' w/ Model "D" packer.

2/8/00 Finish POOH. LD packer. RIH w/ 2 3/8" tubing.

2/9/00 Finish RIH w/ notched collar, 1 jt 2 3/8", seat nipple, 222 jts 2 3/8" 4.7# J-55 tubing. Landed at 6929'. ND BOP, NU wellhead. RDMO.
