Conoco requests to temporarily abandon this well. This well is shut-in due to uneconomic gas production associated with high water production. During the plug and abandon we will try to identify the source of water production, determine the cost of shutting the water off and make an economic determination on whether the well can be restored to production. Temporary plug and abandonment procedures will be sent by January 15, 2001.
