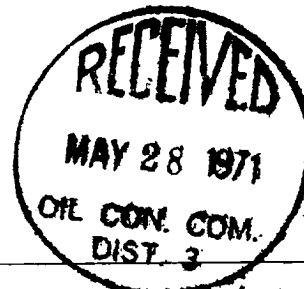

3-29-71 Cleaned out to 6250'. Perforated 6220' to 6204' with 1 shot per foot and from 6204' to 6178' with 2 shots per foot. Acidized with 500 gallons mud acid. Initial BDP 1000#, broke to 700#. TP 1500# at 2.4 BPM.

4-13-71 Sand-oil fraced with 300,000# 20/40 sand mixed with 5,435 barrels crude oil, flushed with 250 barrels. No apparent breakdown pressure. Average overall injection rate 71 BPM. Maximum TP 2200#, min. 2000#, average 2100#. Inst. SDP 1500#.

4-28-71 Finished cleaning out sand. Started measuring fluid levels.
