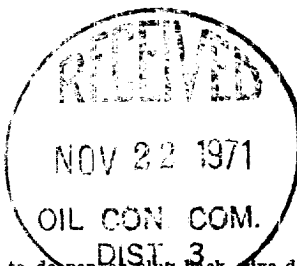

We are proposing to drill and equip AXI Apache Well No. 23 to test for commercial production in both the Chacra and Mesa Verde zones. The well will be drilled to a total depth of 5275' with rotary tools. All appropriate logs will be run and no coring or DST's are planned. If commercial production exists, the well will be completed by running production casing as indicated above. The rig will be equipped with a blowout preventer.

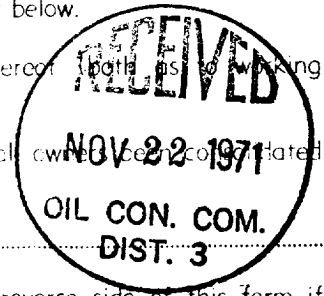

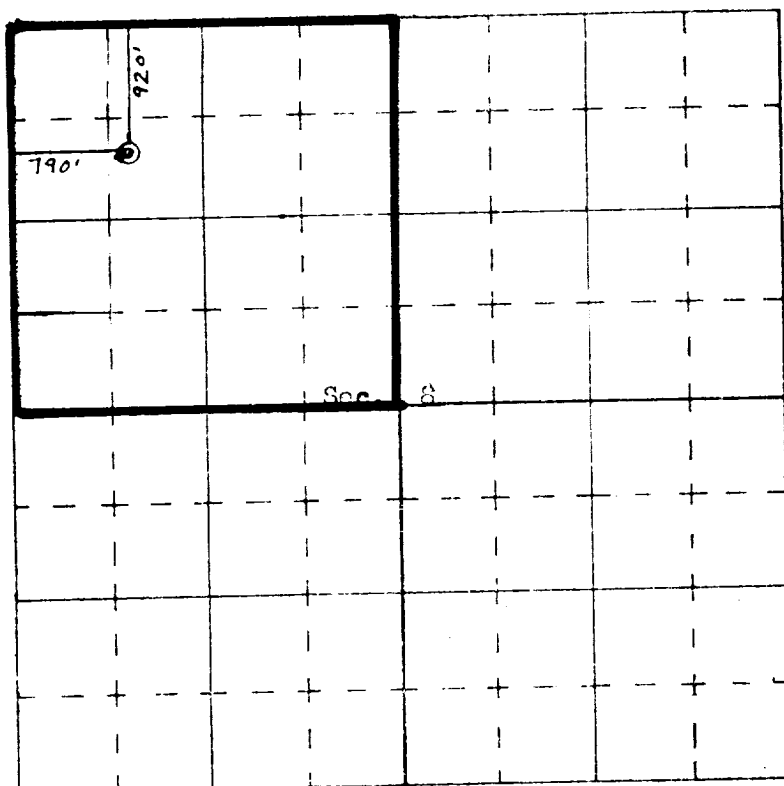
