- If well circulated, TIH open ended w/ 1 1/4" or 2 3/8" workstring to 2985'. Pump 38 sx (44.8 cuft) cmt, spotting cmt from 2494' to 2985'.
- WOC. Tag cmt.
- If well will not circulate, procede with approved P&A procedure.

FOR
OIL AND GAS OPERATIONS FEDERAL & INDIAN LEASES

1. Plugging operations authorized are subject to the "General Requirements for Permanent Abandonment of Wells on Federal and Indian Leases."
2. For wells on Indian leases, Bryce Hammond with the Jicarilla Nation Tribal Oil and Gas Office is to be notified at least 24 hours (48 hours if possible) before the plugging operations commence. 3. Blowout prevention equipment is required.
4. The change dated 10/23/01 is approved as filed. The procedure will revert to the previously approved procedure dated 5/23/01.
