1-13-99 MIRU. ND WH. NU BOP. TIH, tag up @ 2333'. Establish circ w/12 bbl wtr. Plug #1: pump 30 sx Class "B" neat cmt inside csg @ 1320-2320'. TOOH to 1150'. Circ hole clean w/20 bbl wtr. TOOH. WOC. SDON.

1-14-99 TIH, tag TOC @ 1735'. Load hole w/5 bbl wtr. PT csg to 500 psi, failed. Establish circ down csg & out bradenhead. Plug #2: pump 8 sx Class "B" neat cmt inside csg @ 1445-1735'. Displace to 1440'. TOOH. WOC. TIH, tag TOC @ 1530'. TOOH. TIH, perf 2 sqz holes @ 559'. TOOH. TIH w/cmt retainer, set @ 505'. TOOH. Establish injection. Plug #3: pump 51 sx class "B" neat cmt below cmt retainer @ 457-559. Pump 4 sx Class "B" neat cmt above cmt retainer inside csg @ 362-507'. TOOH. TIH, perf 2 sqz holes @ 182'. TOOH. Establish circ down 2 7/8" csg & out bradenhead. Plug #4: pump 65 sx Class "B" neat cmt down csg & out bradehead. Circ 1 bbl cmt to surface. WOC. SDON.

1-15-99 ND BOP. Cut off WH. Install dry hole marker w/15 sx Class "B" neat cmt. RD. Rig released. Well plugged & abandoned 1-15-99.
