- 10-9-95 Moved in and rigged up A-Plus Well Service. Nippled up and blew down lines. Tubing, casing & bradenhead pressures all zero. Changed over for 1-1/4" tbg. Nippled down wellhead; nippled up BOP. Tested BOP - OK. Tallied 1-1/4" tbg. out of hole - 207 jts. Pumped 15 bbls. water down the tbg. Plug #1: mixed & pumped 56 sx 15.3# cement (63.6 cu.ft.) from 3480' to TOC at 2742'. POOH, laying down all the tbg. WOC 1 hr. Tested csg. to 500 psi - OK. TIH & tagged TOC at 2862'. Pulled up hole & perforated 2 holes at 263'. POOH with wire line. Loaded the hole thru casing; circulated out perfs at 263' thru the bradenhead. Plug #2: Mixed & pumped 79 sx 15.2# cement (94.8 cu.ft.), from 263' with good cement returns out the bradenhead. Shut well in at 4:30 pm.
- 10-10-95 Rigged down BOP. Cut off wellhead below ground level. Installed dry hole marker & information plate. Moved off location.
- 10-11-95 Notified USFS of plugging job completion.
