4/25/02 TIH with packer and acidize with 1000 gals 15% HCL. TOH with packer.

4/26/02 RU Halliburton. Fracture well with 39,917 gals 60Q foam and 87,600# 20/40 sand. RD Halliburton.

4/27-28/02 Flow back well.

4/29/02 TIH with RBP retrieving tool, tag sand at 7319'.

4/30/02 Clean out to RPB, latch onto same and TOH. TIH with 2 3/8" tubing, land at 7782'. ND BOP, NU wellhead.

5/1/02 RDMO.
