#### Gentlemen:

Benson-Montin-Greer Drilling Corp., operator of the Canada Ojitos Unit, hereby requests under Rule 4 of the Pool Rules (Order R-6469-A) administrative approval of the captioned unorthodox location.

Reason for the unorthodox location is topography. We desire that the well be located on the Simon Canyon drainage. The land is located within the Santa Fe National Forest, and we have agreed with the Forest Rangers to improve the Simon Canyon road. As can be seen from the topographical map enclosed (copied from the Llaves 15 minute series topographic quadrangle) the location of the Continental Divide eliminates all locations in Section 32 satisfying this requirement except the unorthodox one hereby requested. The standard "window" in the NE/4 of Section 32 called for by Order R-6469-A is shown as a square on the accompanying topographic map, along with the proposed unorthodox location shown with a circle.

By copy of this letter we are notifying operators whose interests have not been committed to the Canada Ojitos Unit but who have leases within sections offsetting (or diagonally offsetting) Section 32 of this request. In accordance with Rule 4 of Order
