Moved in and rigged up Four Corners Drilling Co. Rig #7. Spudded 12 1/4" hole at 9:30 PM 6/30/85. Drilled to 265'. Ran 6 jts. of 9-5/8", 36# casing J-55 LT+C set at 264' RKB. Cemented with 145 sx class "B" with 2% CaCl<sub>2</sub> (171 cf). Plug down at 2:30 a.m. 7/1/85. Circulated 1/2 bbl. cement to surface.

Waited on cement 10 1/2 hrs. Tested surface casing to 1000 psi for 1 hr. Held OK.
