Spud a 12 1/4" hole on 10-23-85 at 1745 hours. Drilled to 442'. Set 8 5/8", 24#, K-55 casing at 442' and cemented with 325 cu. ft. Class B Ideal. Circulated cement to surface. Pressure tested casing to 1000 psi for 30 minutes. Drilled a 7 7/8" hole to a TD of 4879' on 11-4-85. Set 5 1/2", 15.5#, K-55 casing at 4879'. Cemented with 709 cu. ft. Class B Portland and tailed in with 224 cu. ft. Class B Portland. Circulated cement to surface/
No DV tool was set and the rig was released on 11-5-85.
