Mallon Oil Company acquired the gathering and compression facilities previously owned by Phelps Dodge Refining Company and known as their "Gavilan Plant" in October 1992. Phelps Dodge dismantled, removed, and sold separately the processing portion of the plant. Since Mallon is no longer selling gas to Phelps Dodge at the well site receiving points, Mallon is requesting authorization for off-lease measurement and sales for the gas. All gas is still measured at respective well site meters as well. The gas is now sold to El Paso Natural Gas at their sales meter located in SW/4 SE/4 Sec. 11, T25N, R2W.
