Proposed Work: Plug back above present producing zones, recomplete Mesa Verde Ss. and produce alone. General Procedure:

1. Set CIBP at 7970', above Dakota perfs 7002-7390'. Spot 10 sx class "B"
2. Set CIBP above Mancos perfs (7002-7390') @ 6990'. Spot 10 sx Class "B" cement on top of plug (cement top 6900').
3. Shoot block squeeze holes 5870' and 5000', set cement retainer at 5850'. Block squeeze with 250 sx "B" + 2% Bentonite and 0.5% Dispersant.
4. Perforate 5829-5433' (Gross), breakdown perfs with HCl and perform sand-water frac on zone.
5. Produce as single zone well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
