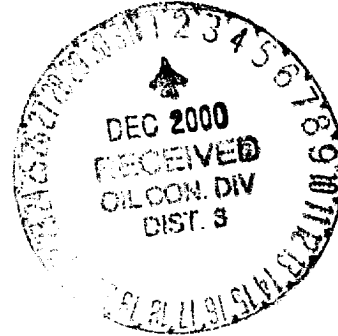

Gentlemen:

McElvain Oil and Gas Properties, Inc. requests administrative approval of this non standard footage location pursuant to Rule 104.F(2). This well was originally permitted and drilled as a West Lindirth Gallup Dakota test. The well was completed and subsequently plugged and abandoned. McElvain proposes to re-enter the well and complete in the Mesaverde. The footage of the well does not meet the set back requirements for the Blanco Mesaverde Pool from the west line of the proration unit boundary.

As required by Rule 104.F(3) the following items are attached:

- A C-102 showing the well location and proposed spacing unit.
- A plat showing offset Blanco Mesaverde spacing units or leases if the sections are not spaced.
- A list of the operators or lessee of record for the offsetting proration units with their addresses.




