

5/4/00 CSG press. 200# blow well down. POOH with TBG., Bit and scraper. RIH with mule shoe collar, seat nipple, and 246 joints of 2 3/8" TBG. end of TBG at 7760'. Drift in. Land TBG. RDBOP, RUWH. RU SWAB, RIH with SWAB to SN. No tight spots. POOH with SWAB. Rig down pulling unit move off.
