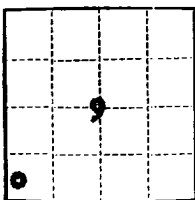

If commercial production is encountered, 5-1/2" OD production casing will be set at approximately 5450' and cemented. All possible producing horizons will be adequately cored and/or tested.

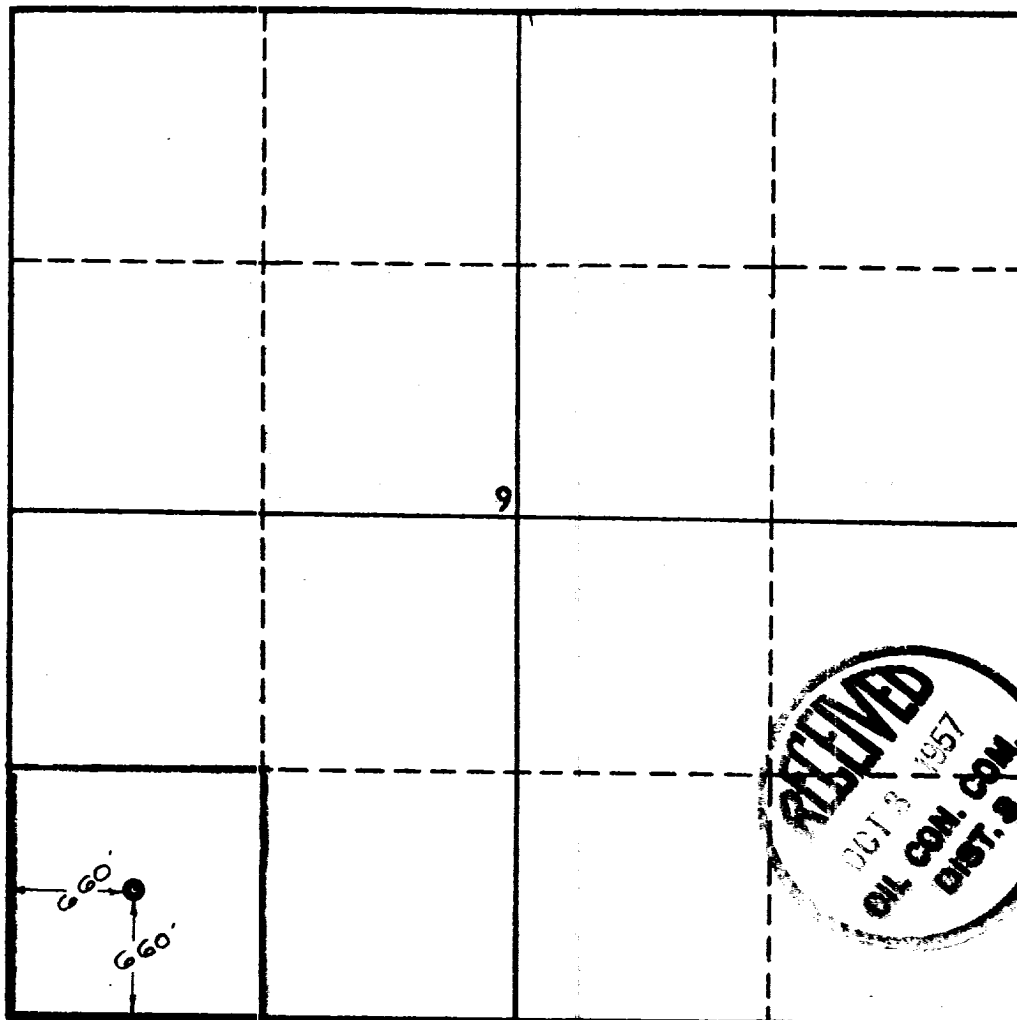
