Top of cement at 4320'. Perforated from 5348' - 5364' & from 5380' - 5394' w/4 bullet shots per foot. Sand-oil fractured w/29,400 gals. lease crude and 45,000# sand at ave. inj. rate of 41.6 bbls./min. at 2550#. Used 120 rubber balls.

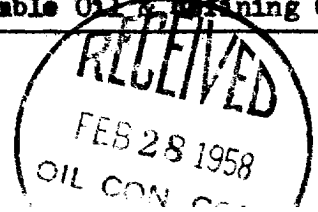
