Spud at 6:30 PM 11-3-67. Drilled 13-3/4" hole to 1191' and set 9-5/8" OD, 12.30#, H-40, 8R, ST&C casing at 1190' AKB. Cemented with 750 sacks common cement with 4% gel, 2% CaCl and 1/4% floccle per sack, followed by 50 sacks common cement. Used pump and plug method. Circulated cement. Plug down at 2:20 PM 11-6-67. Released pressure. Floats held ok. WOC 12 hrs. Test casing and BOP to 1200 psi for 30 minutes. Held OK. Drilling 8-3/4" hole below surface casing.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
