A 12-1/4" hole was spudded at 3:00 pm, 11-12-75, and drilled to 290'. Reamed to 17-1/4" hole to 290'. Set 13-3/8" casing at 290' with 350 sacks Class "B" cement with 2% CaCl₂ on 11-13-75. Circulated good cement. WOC. Tagged cement at 265'. Tested casing blowout preventer and manifold with 500 psi and continued drilling.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
