The above referenced well ceased production due to casing leak on August 29, 1986. On September 10, 1986 a pulling unit was moved in and rigged up. Well was swabbed, recovering only muddy water with some sand; indicating well has casing leak. Well shut in on September 12, 1986 pending evaluation for possible repair of casing leak on recompletion.
