Dear Ms. Wrotenbery,

We are writing to request your administrative approval for a ± 160.76 acre non-standard spacing unit comprising the NE/4 of Section 5, T-24N, R-9W for the existing Basin Fruitland Coal completion in Dugan Production's Phillips No. 1 well.

The Phillips No. 1 was completed on 10-1-87 testing a rate of 61 mcfd @ 3 psig from perforations 1704'-1713' in a Wildcat-Fruitland pool and perforations 1714'-1717' in a Wildcat-Pictured Cliffs pool. The spacing unit for both completions was the NE/4 with Dugan Production holding 100% of the working interest. Since the Phillips No. 1 had tested a fairly marginal producing rate, was not close to a gas pipeline and was in a sparsely developed area, it was shut in until there was sufficient development in the area to warrant the construction of a pipeline.

Upon adoption of pool rules for the Basin Fruitland Coal (effective 11-1-88) we inadvertently did not include the Phillips No. 1 in our efforts to bring Dugan's existing coal completions into compliance with the newly adopted pool rules, i.e., we did not obtain NMOCD approval for a non-standard unit for the Fruitland coal completion. The Phillips No. 1 remained shut in until 10-2-00 at which time it was connected to Dugan's Goodtimes Gas Gathering System which had been extended to include the Phillips No. 1. Upon reviewing well records, it was discovered that the Phillips No. 1 was considered to be a shut in Fruitland Sand (plus Pictured Cliffs) completion.

In an effort to correct the well completion records to reflect perforations 1704'-1713' as being in the Fruitland Coal rather than a Fruitland Sand, we need to either establish a north half, ±320 acre spacing unit or secure a ±160 acre NSPU. Since all activity on this well to date has been based upon a 160 acre spacing unit consisting of the NE/4, we are proposing to maintain a 160 acre spacing unit. All expenditures to drill, complete, test and connect the well to Dugan's Goodtimes Gas Gathering System have been based upon a NE/4 spacing unit held 100% by Dugan Production Corp. In addition, the NE/4 has been communitized for production from the Fruitland and Pictured Cliffs (CA No. NM015P35-87C-337) and the Fruitland/Pictured Cliffs have been approved for downhole commingling (DHC-680 dated 11-13-87).

Based upon production testing to date, we do not anticipate the Phillips No. 1 will produce significant volumes of gas (production during January, 2001 averaged 5.0 mcfd plus 10.3 bwpd). Commingled production data for the Fruitland Coal and Pictured Cliffs is summarized as follows:

Should production volumes increase such that correlative rights of the owners in the NW/4 are at risk, we will take steps to protect the interests in the NW/4 of this section, which consists of federal lease NM-97108 and is held jointly by Dugan Production Corp. (99.5%) and James B. Fullerton (0.5%). We have discussed this proposal with Mr. Fullerton and he has no objection to producing the Phillips No. 1 with a NE/4, non-standard spacing unit. Attachment No. 1 is a copy of a waiver signed by Mr. Fullerton. All leasehold interest in the N/2 of Section 5 consists only of federal leases and thus there should not be any issue of correlative rights for the mineral interest owner as a result of forming a 160 acre NSPU for the Phillips No. 1. Attachment No. 2 presents the leasehold ownership of all lands offsetting the N/2 of Section 5. All offset interest owners are being provided a copy of this application and Attachment No. 3 is a copy of the transmittal letter which was sent by certified mail with return receipt requested. Upon receiving all return receipts, we will forward copies to the NMOCD as proof of notification to offsetting interest owners.

The Phillips No. 1 is located on the southern edge of the Basin Fruitland Coal pool and is in an area that has had little development to date in the Fruitland Coal. The only other Fruitland Coal wells in this area were also completed by Dugan Production. The Mo Valley No. 90, located in the SW/4SW/4 of Section 5 (T24N-R9W) was completed on 4-15-98 and has been producing since 1/00. Production during 1/01 averaged 30 MCFD plus 9.7 BWPD. Attachment No. 4 presents the production history for the Mo Valley #90. The Sanchez O'Brien No. 90 is located in the SW/4SW/4 of Section 6 (T24N, R9W) and was completed on 10-26-98. This well has been producing since 2/00 with production during 1/01 averaging 9.8 MCFD plus 11.3 BWPD. Attachment No. 5 presents the production history for the Sanchez O'Brien No. 90.

Based upon the production to date from all 3 wells, we are fairly confident that production from the Phillips No. 1 well will not create a drainage concern for leases in the NW/4 of Section 5. Thus, as provided for in Rule No. 6 of the subject pool rules, we respectfully request your administrative approval for a 160.76 acre NSPU comprising the NE/4 of Section 5, T24N, R9W. This will allow Dugan Production to produce a fairly low volume well which we completed in Wildcat Fruitland and Pictured Cliffs pools prior to the establishment of pool rules for the Basin Fruitland Coal. To date, all activity on this well has been based upon a NE/4 spacing unit. The south half of this section is dedicated to Dugan's Mo Valley #90 and the NW/4 is jointly owned by Dugan Production plus one other interest owner which has signed a waiver indicating he has no objection to the Phillips No. 1 being produced on a 160 acre NSPU for the Fruitland Coal. All offsetting interest owners of the undeveloped acreage have received a copy of this application and since the Phillips No. 1 is fairly remote with respect to the established Fruitland Coal development we anticipate there will be no objection from offset interest owners.
