Drilled 7 7/8" hole to 5884'. Ran 134 jts. of 4 1/2" 11.6# casing x set at 5878'. Cement with 600 sks. 65/35 poz w/12% gel x 6# per sack gilsonite followed by 250 sks. 50/50 poz w/2% gel x 10% salt. Plug down at 6:15 a.m. 10/29/90. Circulated 15 Bbls. of cement to surface. Tested casing to 1500#.
