Moved in & rigged up Four Corners Drilling Company Rig #4. Spudded a 12-1/4" hole at 11:00 A.M. 3-25-92. Drilled to 230'. Ran 5 jts. 8-5/8" OD, 24#, 8 Rd, ST&C casing (T.E. 209') set at 221' RKB. Cemented with 150 sx class "B" plus 2% CaCl₂ (total cement slurry = 177 cu.ft.). Circulated 3 bbls cement to surface. P.O.B. at 2:15 P.M. 3-25-92. Waited on cement 11-1/2 hrs.

Pressure tested casing and BOP 1000 psi for 30 minutes - held OK.
