Cement with 70 sx class "B" neat with 2% CaCl₂ (83 cu.ft.). Displace with 6 bbls water. Plug down 1600 hrs 11-3-95. Circulate 2 bbls cement.

Nipple up BOP. Pressure test 500# - held OK.
