Drill to 1850' TD on 6/23/99. Run 4-1/2" 10.5 casing at 1849'. Cement with 244 cu. ft. 2% Lodense with 1/4#/sk celloflake, tail with 83 cu. ft. Class "B" with 1/4#/sk celloflake. Circulate 8 bbls cement to surface. Total volume of cement 327 cu. ft. Job complete 6/24/99.
