## DETAILS OF WORK

On 12-14-56 ran 105' 3 5/8" 21# J-55 new casing set at 114' and cemented with 30 sacks cement. Cement circulated. After WOC 48 hours Tested casing with 800# for 30 minutes. Held OK.

On 12-19-56 ran 2258.52' of new 5 1/2" 15.5# J-55 4000# T casing (65 joints) set at 2267' and cemented with 150 sacks cement. Perforated 5 1/2" 2142-2214 with 4 jet shots per foot. Brokedown formation with 250 gallons mud acid. Fraced through perms with 43,534 gallons water and 60,000# sand. Formation broke at 1500#, maximum treating pressure 2300#. Average injection rate 38.3 BPM.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
